

# If you made a food delivery order through Chick-fil-A, Inc.'s Chick-fil-A® App or website between November 1, 2019, and April 30, 2021, you may be entitled to an award from a class action settlement.

*A state court has authorized this Notice. This is not a solicitation from a lawyer.*

**What is this About?** A Settlement has been reached in a class action lawsuit to resolve a lawsuit against Chick-fil-A, Inc. ("Chick-fil-A" or "Defendant"), relating to allegations that Chick-fil-A made false or misleading representations regarding its delivery fees and menu prices for its delivery orders between November 1, 2019 and April 30, 2021. Chick-fil-A denies these allegations and denies any wrongdoing. By entering into the Settlement, Chick-fil-A has not conceded the truth or validity of any of the claims against it. The Court has not decided who is right. Instead, the parties have agreed to the Settlement.

**Who is included?** You received this email because Chick-fil-A provided information under the Settlement indicating you likely are a Class Member. You are a Settlement Class Member if you made a Chick-fil-A delivery order through the Chick-fil-A® App or website between November 1, 2019, and April 30, 2021, from a Chick-fil-A location in California, Florida, Georgia, New Jersey, or New York.

**What do the Settlements provide?** As a Settlement Class Member, you can file a Claim to receive either a Cash Settlement Award or a Gift Card Settlement Award up to \$29.25. You will have the option to select to receive either a Cash Settlement Award or a Gift Card Settlement Award when you file a Claim.

**How To Get Benefits.** You can use your Claim ID number shown at the top of this email to file your claim online [here](#) at the settlement website, [www.DeliveryOrderSettlement.com](http://www.DeliveryOrderSettlement.com). The deadline to file a claim online is **11:59 p.m. PST on February 15, 2024**. You must file a claim to receive an Award.

**Your Other Options.** If you do not want to be legally bound by the Settlement, you must exclude yourself by **January 2, 2024**. If you do not exclude yourself, you will release your claims against Chick-fil-A. You may object to the Settlement by **January 2, 2024**. The [Detailed Notice](#) available on the website explains how to exclude yourself or object. The Court will hold a Hearing on **February 29, 2024**, to consider whether to approve the Settlement, up to \$880,000 for attorneys' fees, plus litigation costs, Service Awards of up to \$5,000 each for the Class Representatives, as well as any objections. You may appear at the hearing, either yourself or through an attorney hired by you, but you don't have to.
